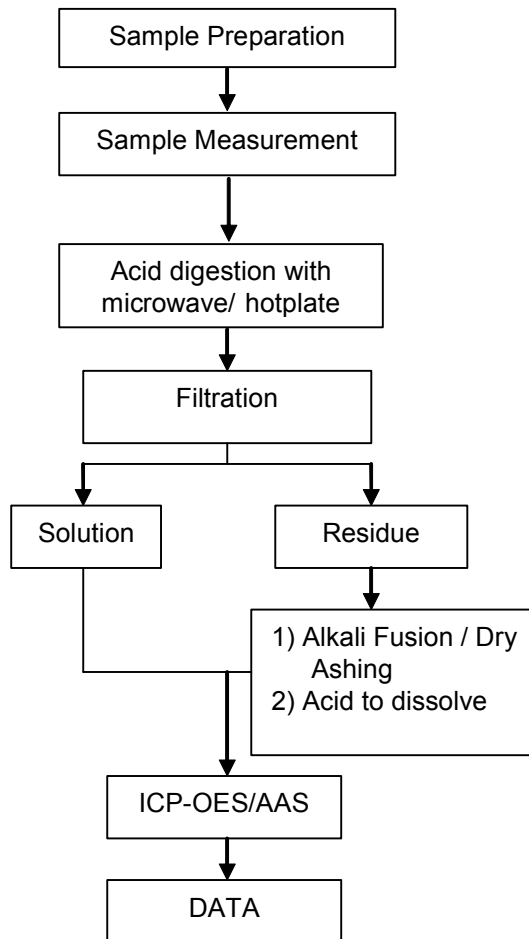

Elements (IEC62321) Testing Flow Chart

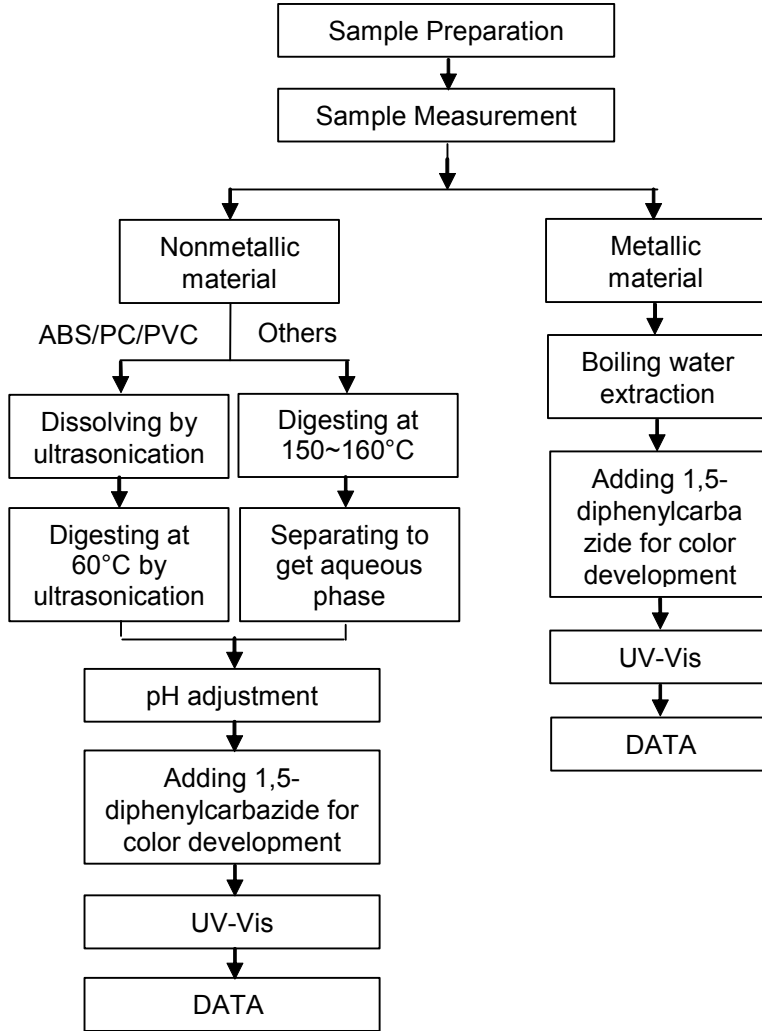

Hexavalent Chromium (Cr(VI)) Testing Flow Chart

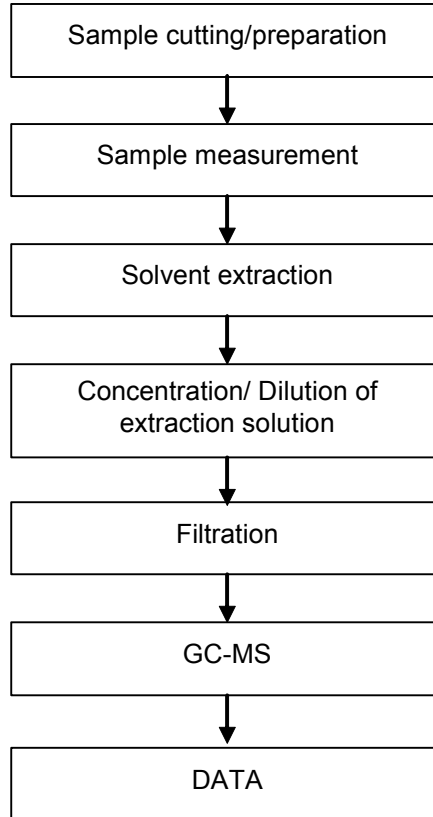

PBBs/PBDEs Testing Flow Chart

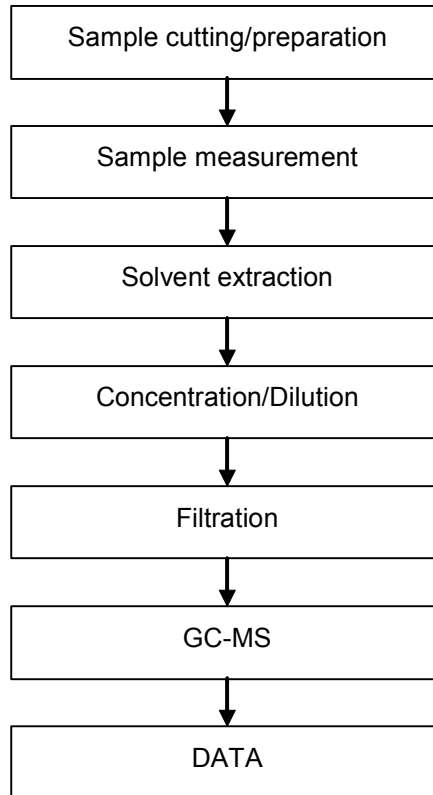

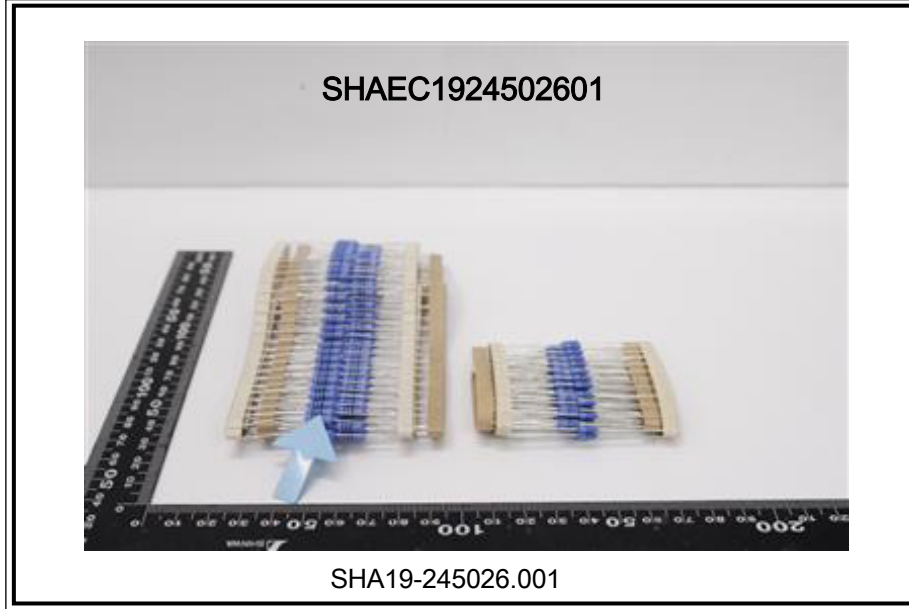
Phthalates Testing Flow Chart
